→ Overview

This conference will address liability for medical malpractice and compensation for medical injuries from 14 national and regional perspectives drawn from 6 continents. This is an excellent opportunity to gain a broader perspective on a common problem in many legal systems and the many solutions adopted. It offers a truly global comparative analysis. The conference aims to consider:

- The overall scheme for preventing and redressing medical errors and adverse events, including regulation, criminal and civil liability, social and private insurance, and the relationships among these various systems.
- The details of the applicable liability and compensation systems.
- Available empirical data on medical errors and adverse events, the operation of the systems designed to prevent and/or redress such errors and events, and the prevalence and impact of measures designed to reduce medical errors and adverse events, improve system performance or reduce system costs.
- Attitudes and concerns about the liability and compensation systems.

The conference is jointly organized by the Chicago-Kent Law Review and the Institute for European Tort Law in collaboration with the European Centre of Tort and Insurance Law. Papers from the conference will be published as issues 86:3 and 87:2 of the Review and as a title in the Institute's Tort and Insurance Law series (jointly edited by the European Centre of Tort and Insurance Law). The conference will be of interest to both legal academics and practitioners working in the fields of medical malpractice or the wider interaction of legal and healthcare systems as well as those involved in healthcare insurance. The conference is also open to both graduate and undergraduate students and those currently engaged in vocational legal training.

Chicago-Kent Law Review

The Chicago-Kent Law Review began as the "Chicago Kent Review" in 1923 and since then has published well over three hundred issues featuring original works by important scholars in the field of law and beyond. A number of years ago the Law Review adopted an all-symposium format and welcomes suggestions for suitable topics to continue its long tradition of scholarship.

Institute for European Tort Law (ETL) and European Centre of Tort and Insurance Law (ECTIL)

Focusing on European jurisdictions, the Institute for European Tort Law of the Austrian Academy of Sciences conducts comparative legal research

in the field of tort law. With its research, ETL aims to enhance and promote the harmonisation and further development of tort law in Europe and has already developed a reputation as a leading instigator of comparative legal research in Europe. Much of this success is based on the large network of national experts that collaborate on the Institute's various projects. In addition, many of ETL's projects are undertaken in conjunction with ECTIL which itself has long been a leading light in European legal scholarship. ECTIL, an independent association based in Vienna, is a research institute undertaking comparative studies in the field of national, international and common European tort and insurance law. Both ETL and ECTIL provide institutional support for the European Group on Tort Law (EGTL), whose core project is the drafting of Principles of European Tort Law. The results of this project are published in a series of the same name (Kluwer).

Journal of European Tort Law (JETL)

ETL and ECTIL have recently launched a peer reviewed law journal, the Journal of European Tort Law. The JETL is the first law review to be dedicated to this important and dynamic area of European private law. The Journal is published by de Gruyter (Berlin). See further www.degruyter.com/jetl.
